**RELEASE OF LIABILITY**  
**For Rider Engaging in Equestrian Activities**

I, \_\_\_\_\_, hereafter known as 'Rider,' knowingly and willingly participate in equestrian activities including but not limited to riding, grooming, catching, feeding, handling, or otherwise being near horses. I acknowledge that horseback riding and equestrian activities carry inherent risks of injury, damage or death to Rider and/or horse, and damage to the farm property. I knowingly assume the risks, known and unknown, of horse-related activities.

**I UNDERSTAND THE INHERENT RISKS OF HORSEBACK RIDING AND EQUINE ACTIVITIES. I AUTHORIZE THAT JOSLYN PRETZ IS NOT LIABLE FOR INJURY TO OR DEATH OF RIDER PARTICIPATING IN EQUINE ACTIVITIES. I UNDERSTAND THAT I AM RESPONSIBLE, ACCOUNTABLE AND LIABLE FOR ANY INJURIES INCURRED WHILE CATCHING, GROOMING, FEEDING, RIDING AND OTHERWISE BEING NEAR HORSES BELONGING TO OR IN THE CUSTODY AND CARE OF JOSLYN PRETZ, INCLUDING BUT NOT LIMITED TO ZELDA, BEAN, BAILEY, JOY AND MUSTANG, AND I WILL NOT HOLD JOSLYN PRETZ ACCOUNTABLE FOR ANY INJURY, DAMAGE OR DEATH TO RIDER BY JOSLYN PRETZ'S HORSES, OR HORSES IN THE CUSTODY AND CARE OF JOSLYN PRETZ, WHILE CATCHING, GROOMING, FEEDING, RIDING OR OTHERWISE HANDLING THE HORSES IN THE PRESENCE OR ABSENCE OF JOSLYN PRETZ.**

I expressly assume any and all risks associated with equestrian activities, whether foreseeable or not. I understand the propensity of horses, including Zelda, Bean, Bailey, Joy, Mustang and others, to behave in dangerous ways which may result in injury to Rider. I understand the inability to predict a horse's reaction to sound, movements, objects, persons, and animals. I also understand the hazards of surface or subsurface conditions, risks associated with sporting events, risks associated with spectator events, and risks associated with the participation in or presence around equestrian events.

I agree to the following:

(A) I am and will be responsible and liable for any and all injuries including, but not limited to physical injury, economic or pecuniary injury, mental or emotional injury and property damage arising from, related to, based upon, or attributable to the acts or omissions of Rider and/or Joslyn Pretz.

(B) I waive, discharge and release Joslyn Pretz from any liability and/or claim which I or others may now or hereinafter have for any injury including but not limited to physical injury, economic or pecuniary injury, mental or emotional injury and property damage arising from, related to, based upon, or attributable to acts or omissions of Rider and/or Joslyn Pretz.

(C) I waive, discharge and release Joslyn Pretz from any liability and/or claim which I or others may now or hereinafter have for any injury including but not limited to physical injury, economic or pecuniary injury, mental or emotional injury and property damage arising from, related to, based upon, or attributable to acts of Joslyn Pretz's horses or horses in the care of Joslyn Pretz.

(D) I release the liability of Joslyn Pretz for any and all injuries including but not limited to physical injury, economic or pecuniary injury, mental or emotional injury, or property damage arising due to the stable's negligence in relation to the premises and operations of this stable including but not limited to riding, grooming, catching, feeding, handling, or otherwise being near horses owned by or in the care, custody and control of Joslyn Pretz.

I understand that Joslyn Pretz's horses, and horses in the care of Joslyn Pretz, may be young and may be apt to spook, buck, rear, bolt, kick, trample or throw a rider. I understand that horses are dangerous, and I am handling and riding Joslyn Pretz's horses, or horses in the care of Joslyn Pretz, at my own risk.
